## SPOTLIGHT ON POLICY

#### **UPHOLDING INTEGRITY: OUR COMMITMENT TO ETHICAL CONDUCT**

As public employees, we're held to a higher standard – we need to operate in a manner that fosters public trust, integrity, equity and transparency. The City's Ethics Policy helps prevent undue influence, conflicts of interest, favoritism, bias and the appearance of impropriety. The policy is based on the <u>Ohio Ethics Law</u>. Some things to note:

- City employees cannot request or accept gifts from improper sources, including vendors
- City employees cannot also work for an improper source
- City employees must avoid conflicts of interest
- City employees must protect confidential information

There are resources to help you navigate any ethical questions! Each year, City employees complete ethics training. Also, the <u>Ohio Ethics Commission</u> has a wealth of information and can provide general guidance.


