PUBLIC ENGAGEMENT SUMMARY

SUMMARY

Columbus Recreation and Parks Department acquired the OSU Agriculture Extension Sheep Farm at 2425 West Case Road for a new community park at the end of 2019. The 58-acre site will become one of the major greenspaces in northwest Columbus. The parkland has a wide range of possibilities—from play areas to hiking to nature observation to special programming—all within a short walk of more than 6,000 residents.


Community engagement and feedback is a critical component of the planning and design process for West Case Road Park. The department and the planning team focused on taking input from as many residents and stakeholders as possible. This included stakeholder roundtables, a project website, a public walking tour and a public survey. Through these methods, **more than 1,171 people have engaged with this project**. The following is a breakdown of the community engagement:

- 1,412 unique website visitors
- 5 neighborhood and stakeholder groups
- · 60 public walking tour attendees
- 1,104 survey respondents

This report summarizes the results from the community engagement process.

PROJECT WEBSITE AND PROMOTION

A project website was created to serve as a repository of information about the West Case Road Park Design project to promote opportunities for public engagement and to host updates about the project to inform the general public. Additionally, to reach the widest possible audience for the online survey and public walking tour, several promotion strategies were utilized, including social media posts and events, email newsletters, the placement of yard signs on-site and in the northwest Columbus area, and the distribution of flyers to adjacent residential developments.





STAKEHOLDER ROUNDTABLES

The planning team met with several key stakeholders to gather their input and to identify challenges and opportunities related to the park design. The stakeholders included representatives from Misty Meadows neighborhood, Trotters Chase Condominiums, Bethel Village Condominiums, Friends of the Historic Sheep Farm and Daniel Wright Elementary School. The following is a summary of the key takeaways from these conversations:

- A connection from West Case Road Park to Carriage Place Community Center is necessary and feasible.
- Connections to the park are also important from the adjacent neighborhoods and residential communities.
- Efforts should be made to preserve and repurpose the homestead and barn.
- There is an opportunity to develop a regional river-to-river connection that spans from the Olentangy River to the Scioto River.
- Any active recreation uses should be located closer to West Case Road.
- Carriage Place Community Center is outdated, and the programming does not serve certain segments of the community, especially the older adult population.

On Oct. 16, 2021, from 10 a.m. – 12 p.m., the planning team hosted a public walking tour at the West Case Road Park site to encourage people to visit the site, allow them to meet with the planning team and to have them complete some activities to learn more about their vision for the site. The activity stations included: (1) welcome, (2) park opportunities, (3) desired activities, (4) other parks visited, and (5) building tours. More than 60 people attended the public walking tour. The results from the activity stations are summarized on the following pages.













Where do you live? (n = 49)


In order to reach the widest possible audience, an online public survey was created and promoted. The survey was live from Sept. 16 - Oct. 31, 2021. The survey was promoted through yard signs around the site and surrounding areas, flyers to the adjacent residential communities, the department's social media channels and email newsletters, and through the project website.

In total 1,104 people filled out the survey, which includes 13 people who filled out a paper version of the survey at the Public Walking Tour held on Oct. 16, 2021, at the park. The following pages summarize the results from the survey.


2. How often do members of your household currently visit West Case Road Park? (n = 816)

The majority of survey respondents are familiar with West Case Road Park and have visited the park.


3. If your household has visited, how do you currently use the park? Select all that apply. (n = 509)






4. Please select up to 5 park features your household would most like to see at the new West Case Road Park. (n = 946)




5. If you selected "Athletic Fields" in your response to Q4, please specify the type of use. (n = 203)




7. Which of the following connections to West Case Road Park would be important to your household? Select all that apply. (n = 946)








12. Does your household live within the City of Columbus boundaries? (n = 915)


13. In what ZIP code do you live? (n = 910)




14. Please select the age categories of all household members who would visit the new West Case Road Park. Include yourself and select all that apply. (n = 910)
